One Smart Class room is maintained in the college. There are 18 class rooms

Examination and Evaluation of answer books are conducted as per university rules. College provides technological edge for the benefit of the students in the form of classes through power point presentation through projectors, classes, unit tests as conducted by Sant Tulsidas College. Assessment of teaching is done through feedback from the students. The college has wiFi facilities in place. The teaching aids are being provided so as to help promote studies in better way. The students are also provided library and internet facilities. The number of books are only 3928. Library and facilities. should be updated in tune with the times.

Faculty members are motivated to undertake research projects and publications. It is noted that during Covid 19 Pandemic, no seminars were conducted. Taking into consideration the need and value of research the faculty members are always motivated to publish their research papers in reputed international journals, as a result, the faculty members have published research papers in UGC recognized/Care listed/ refereed/peer-reviewed journals. For the Promotion of Research Skills and Aptitude students have been allowed to Participate in research project competitions. To develop entrepreneur quality among the students 'Start-up' and Innovation cell' organizes and sends students for attending workshops and experts lectures. In order to promote Social responsibility among the staff and students the College conducts various activities like tree plantation program, drug de-addiction campaign and Blood donation programmes.

The Sant Tulsidas College started from 2010 in its own building. It total area of land is 6.19 Acres. And the Built-up area is 64924 sq.feet of space. The College is having a Principal's Chamber, Accounts Section, Fee Counter, Staff, Room, Laboratories, Library, College Office, Boys & Girls Common Room, Computer room, Separate toilet for Boys & Girls, Examination Department, N.S.S. room and 18 class rooms furnished as per requirement. The College campus has enough space for parking of vehicles & cycles. The college is well covered by CCTVs and proper fencing. Facilities for students like Canteen, Sports and games and arts needs timely advancements.

There are less numbers of Journals, Magazines and publications. The college should have inflibnet facilities for the Library. The Library and the office facilities need to be Automated. The laboratory facilities need to be enriched and enhanced. Women friendly facilities like Vending Machines, Health Check-up rooms and medical facilities need to be provided. For students in general toilet facilities, hygienic canteen facilities need to be provided. Ramp facilities for physically challenged students, incinerators for waste management also should be provided. For extraction of for natural energies, the rain harvesting system, solar energy extraction and wind mills can be installed.
